Record-high Ahtna Shareholder Dividend Declared

For the first-time, distributions will be made from Ahtna's Settlement Trust

Anchorage, Alaska – On November 6, 2018, in accordance with the Earnings Distribution Policy, the Trustees of Ahtna Hwt-anene (People's) Trust formally declared a record-high shareholder distribution for 2018 of \$10.27, or \$1,027 per 100 shares. The distribution will be made to all shareholders of record as of November 5, 2018. The 2018 distribution is more than double that of Ahtna's 2017 dividend and is the highest dividend/distribution per share in the history of Ahtna.

In addition, a distribution of \$1,000 per eligible Elder as of November 5, 2018 was declared. Since 2009, an Elder distribution to original shareholders age 62 and older has been provided.

The combined total of both distributions represents a record distribution for Ahtna and is an increase from the prior record of 90 percent.

Both distributions are scheduled to be mailed November 30th or deposited November 20th for those signed up for direct deposit. For 2018, shareholder and elder distributions are **NOT** taxable.

About the Ahtna Hwt-anene (People's) Settlement Trust

In 2013, the Ahtna Hwt-anene (People's) Settlement Trust was established to provide a means for Ahtna to pay stable, non-taxable dividends to shareholders in perpetuity. Ahtna made its first contribution to the Trust in 2015 by transferring \$3.4 million from Ahtna's investment portfolio. The Board of Directors Earnings and Distribution Policy sets guidelines for distributing earnings with ten percent in contributions each year going to the Trust.

Ahtna, Incorporated is one of 13 Alaska Native Regional Corporations formed under the Alaska Native Claims Settlement Act of 1971, and is based out of Glennallen, Alaska.
